The Harrison County Community Foundation (HCCF) is providing funding to cover childcare costs for healthcare, emergency services and essential workers.

HCCF is partnering with Blue River Services (BRS), the Boys and Girls Club of Harrison County (BGC) and the YMCA of Harrison County to provide a safe and age-appropriate option. Healthcare workers, emergency services workers and those employees working in essential services can register their children for free childcare by directly contacting the providers. Each provider has different hours and services available.

BRS Rainbow's End, at 310 South Capitol Avenue in Corydon, is accepting children from one year through 12 years old. Parents can register by calling 812-738-1979.

BGC, located at 134 Jenkins Court NE in Corydon, is conducting registration on its website, [www.hc-bgc.org](http://www.hc-bgc.org).

YMCA, located at 198 Jenkins Court, in Corydon, is conducting registration on its website, [www.ymaharrison.org](http://www.ymaharrison.org). Parents must register their child at least 12 hours in advance.

With the extension of Governor Eric Holcomb's "stay at home" order for Hoosiers to slow the spread of COVID-19, **Harrison County Public Library facilities will remain closed through Tuesday, April 21.**

HCPL is always open 24 hours a day, seven days a week [on the HCPL webpage](#) with access to eBooks, eMagazines, downloadable audiobooks and other eResources. To ensure library patrons have access to library eResources, library card privileges have been renewed for all library cards that would have expired January 1 through June 30, 2020. The new card expiration is now December 30, 2020. Harrison County residents who do not currently have a library card can access library eResources by **applying for a Digital Access Card** at the bottom of the **Library eResources page**.

Material due dates have been extended until after May 3. No library materials will be due during the March 17 - April 21 closure.

Library Wi-Fi remains on at all library locations, and can be accessed outside the buildings and in the back parking lot at the Main Branch in Corydon.
