



HCCF OFFERS MULTIPLE SCHOLARSHIPS

BUILDING OUR FUTURE SCHOLARSHIPS (BOF)

In celebration of our 10th anniversary in 2006, HCCF began awarding BOF scholarships to graduating high school seniors. These scholarships provide up to \$1,250 per semester and are renewable for four years or a total of \$10,000. In 2021, 24 BOF scholarships were awarded to Harrison County resident students.

INDIANA UNIVERSITY SOUTHEAST (IUS) SCHOLARSHIPS

Starting in 2010, HCCF began awarding special scholarships to graduating high school seniors attending Indiana University Southeast. The scholarship provides up to \$2,500 per semester and is renewable for four years up to a total of \$20,000. Currently, one IUS Scholarship is awarded at each county high school every year.

In addition, HCCF provides scholarship opportunities for students pursuing vocational training through the **FOUNDER'S VOCATIONAL SCHOLARSHIP PROGRAM (FOUNDER'S)**. In 2021, HCCF awarded six Founder's scholarships to graduating high school students.

In 2011 HCCF began funding the **"HAND UP" SCHOLARSHIP PROGRAM** primarily for adults seeking vocational training. In 2021 the HCCF Board voted to begin allowing Harrison County Lifelong Learning to access Hand Up Scholarship funding.

HCCF began providing **ADULT SCHOLARSHIPS** in 2013. These scholarships support Harrison County residents at least 25 years of age, returning to school to finish their Associate's or Bachelor's degrees. The number of adults utilizing scholarships in 2021 slowed to three, a decline attributed to the COVID-19 pandemic.



JESSIE L. AND ARLIE L. FOGAL SCHOLARSHIP FUND

I have lived my entire life in Harrison County and spent many enjoyable years in the field of education. Although not blessed with progeny of my own, I have come to feel that all of the young people in Harrison County, and many not now so young, are about the same as my children. It is my fond hope that those who do benefit hereby will in turn transmit the advantages received by them to the entire citizenry of Harrison County so that Fogal Scholars will be a credit to themselves and to Harrison County.

Dr. Lisa Clunie exemplifies everything Arlie Fogal hoped for when he established the Jessie L. and Arlie L. Fogal Scholarship in his estate plans. Dr. Clunie received the scholarship upon graduation from North Harrison High School. The Fogal scholarship provided for her undergraduate studies at the University of Louisville and her medical degree in 2001 from Indiana University. Dr. Clunie describes feeling overwhelmed with joy when she received news she had been awarded the scholarship. But she also says it meant more than she could possibly understand at the time.

In addition to being Harrison County born and raised, Lisa Clunie had obtained all of her elementary, junior, and senior high school education in Harrison County. She wanted to return to her home community to practice, another piece of criteria Arlie Fogal included in his plans.

Indeed, Dr. Clunie became a beloved physician and practiced medicine locally for 17 years before becoming the Chief Executive Officer of Harrison County Hospital in January 2022. She says she reflected on whether or not she would continue to meet the expectations outlined by Fogal by transitioning into hospital administration rather than continuing as a practitioner. She concluded her new role would allow her to assist even more Harrison County residents than she possibly could as an individual.

Dr. Clunie has experienced philanthropy by being both a recipient and a giver. In addition to numerous community activities, she established her own endowment fund at HCCF. The Dr. Lisa and Jeff Clunie Builder's Fund was created in 2016. Builder's Funds are not restricted to support a particular nonprofit or cause, but rather are flexible so the HCCF Board of Directors can direct them to the most pressing needs in the community at the time. Dr. Clunie said she could depend upon the HCCF Board of Directors to use the money wisely long into the future.

20+ YEARS SUPPORTING OUR COUNTY'S STUDENTS THROUGH SCHOLARSHIPS

Through the years the HCCF scholarship program has expanded. In 1998, HCCF awarded initial scholarships for a total of \$80,000. In 2021 HCCF awarded scholarships totaling \$687,542. Overall, HCCF has awarded more than \$12,500,000 in scholarships since 1998.

Many scholarship funds are started by families in honor or memory of someone special to them. HCCF now holds 118 different endowed scholarship funds.

JUMP START PRESCHOOL FIVE YEAR PILOT PROGRAM REPORT

A child's brain develops more from birth to age five than at any other stage in life. It's vitally important for young children to experience appropriate play and interaction in order to develop emotionally and academically. These early experiences lay the groundwork for a child to achieve success in school and beyond. Research shows children of parents who have higher education levels have significantly larger vocabularies.

Harrison County is home to nearly 40,000 people and includes more than 10,000 families. About eight percent of all families in Harrison County live below the poverty level. Many of those households are at poverty level despite full-time year-round employment.

Armed with this information, the HCCF Board of Directors decided to start addressing the problem, initiating a pilot pre-kindergarten (pre-K) program in the 2013-2014 school year. Jump Start Preschool subsidizes a full day of instruction within a high-quality program for four-year-olds from low-income families.

In the school year 2018-2019, HCCF began partnering with the Indiana Family and Social Services Administration to provide the state's "On My Way Pre-K" (OMWPK) program for four-year-olds in a similar full-day program. If families did not qualify for OMWPK they were encouraged to apply for Jump Start funding.


Participating providers included public and parochial elementary schools with pre-K classes, private secular programs and private faith-based organizations. From the beginning, HCCF contracted with Indiana University Southeast's Applied Research and Education Center (IUS AREC) to evaluate the effectiveness of the program. IUS AREC did not use data from school years 2019-2020 nor 2020-2021 to compile a final report due to the impact of COVID-19 on school systems. A total of 570 children participated in the five-year pilot. A cumulative sample of 435 children was used to provide pre and post data for the report.

On average, student development increased between 15 and 23 months in the actual nine months from pre-test to post-test in each of the three main Indiana Standards Tool for Alternative Reporting Kindergarten Readiness (ISTAR- KR) categories: Reading and Language, Math and Quantitative Reasoning, and Social and Emotional Development

While children do not usually learn how to read until about the first grade, they actually begin developing pre-literacy skills much earlier. "Just having kids know which way is right side up for a book and what direction the pages turn – that makes a big difference," states one Harrison County Kindergarten teacher.

The Jump Start pilot program has been successful, leading to more permanent and widespread implementation of access to high-quality pre-K for Harrison County’s four-year-olds. Data from the project also points to broader needs for support for families of young children.

Quality feedback and language modeling, classroom organization, and attendance rate are just some of the factors that affect the level of success a student may experience. Transportation to and from school continues to be a hurdle for many families to overcome. High quality instruction and parental support are important factors but these alone cannot make up for the first three to four years of brain development.

Families also need access to affordable, developmentally appropriate care for children from birth to age four to support the cognitive, social and emotional development that is essential to ensuring children have the opportunity to reach their full potential. Investments in high quality early care and education provide immediate benefits to local business and the region’s economy. By centering the needs of low-income families, the community is likely to improve the quality of life for all families.

ONGOING PROGRAMS INCLUDE:



DOLLY PARTON’S IMAGINATION LIBRARY PROJECT (DPIL) is designed to encourage parents to read to their children by providing each child enrolled in the program an age appropriate book in the mail each month until their fifth birthday. An average of 1,512 children were enrolled in Harrison County in 2021 with 18,149 books mailed. The Early Readers Fund, which supports DPIL in Harrison County, benefits from a 2:1 donation match provided by HCCF.

The **DICTIONARY PROJECT** provides a dictionary to every third grader in Harrison County. Students attending the nine Harrison County Elementary Schools receive their very own dictionary to use at school and take home. A total of 467 dictionaries were distributed in 2021. A total of 7,088 have been distributed since HCCF began partnering with The Dictionary Project in 2008. The Project’s goal is to assist students in completing the school year as good writers, active readers and creative thinkers.

The **YOUTH PHILANTHROPY COUNCIL (YPC)** of Harrison County is designed to teach skills and encourage youth to give and serve in their communities. The program goals are to promote youth development through experiences in philanthropy, to encourage and support community initiatives which youth care about, and to engage youth through giving and serving for the common good. In 2021 HCCF entered into a one-year pilot partnership with Leadership Harrison County (LHC) to incorporate YPC and LHC’s Youth Leadership Program into one. HCCF provided \$3,000 to support the program’s cost.

In addition, YPC awarded \$600 to the Lanesville High School After Prom program as a part of its grant program. The Youth Philanthropy Fund, which provides youth-led grantmaking dollars, continues to benefit from a 2:1 donation match provided by HCCF.

HCCF offers, **BUILDING DYNAMIC BOARDS OF DIRECTORS** training at no cost to participants upon completion. Four training programs were offered in 2021 with a total of 41 participants.

FOUNDING HISTORY

Harrison County Community Foundation has a unique history. In a Riverboat Gaming Development Agreement dated May 15, 1996, RDI/Caesars Riverboat, LLC agreed with the Harrison County, Indiana government to provide \$5,000,000 to create the Foundation. The three seated county commissioners; Ed Emily, Terry L. Miller, and Kenny Saulman selected 21 Harrison County citizens to become the Foundation's first Board of Directors.

Today, three nonprofit organizations comprise what's commonly known as the Foundation:
Harrison County Community Foundation, Inc. (HCCF)
Harrison County Community Foundation Supporting Organization (HCCF SO)
Harrison County Community Foundation Real Estate Supporting Organization (HCCF RESO)

25TH ANNIVERSARY CELEBRATION

Since 1996, HCCF has been supporting Harrison County, serving nonprofits and benefiting the community. As HCCF entered its second quarter century, the vision for a year of celebration and reflection vanished as the COVID-19 pandemic remained a constant factor. 

For prizes the winners received digital photo frames.



CONTINUING THE THEME OF SHOWCASING 25 YEARS OF SUPPORT

HCCF distributed 100 celebration yard signs throughout the county. Locations included projects and on-going programs where HCCF has played a role.

The culminating event was a time capsule installation held in October. More than 30 items representing people and places that were a part of the first 25 years were carefully selected and deposited into the time capsule. Board Members, Staff, and Members of the Community took part in the ceremony.

Some of the items included a quilted fiber art piece representing 20 different aspects of the county designed and created by a Founding Board Member; a high school graduation tassel to represent scholarships, a catalog listing the more than 300 endowment funds currently held at HCCF; a commemorative 25th Anniversary Zimmerman glass piece, a mortarboard and tassel from preschool graduation; a Dolly Parton's Imagination Library Book; a map outlining broadband internet services in Harrison County which HCCF has played a vital role in expanding; a blank check representing the current Foundation's gift to the future – endless possibilities; and even a mask and article about COVID-19 from the Centers for Disease Control and Prevention.

The plan is to open the capsule 25 years from now in October 2046.

TOWN PLANNING INITIATIVE

The ambitious TOWN PLANNING INITIATIVE moved forward. HCCF utilized the Implementation Grant of \$90,000 and the Board Engagement Grant of \$100,00 awarded in 2020 from Lilly Endowment Inc. toward creating or updating a Comprehensive Plan and an Asset Management Plan for each of the ten incorporated towns in Harrison County.

HCCF committed an additional \$528,624 toward the multi-year project. In 2021 The Wheatley Group and Taylor Siefker Williams Design Group were contracted to oversee the process. Goals include ensuring town residents have the opportunity to provide feedback in creating plans that can be used to leverage outside funding for infrastructure projects in the future.

HCCF CONTINUES EFFORTS TO MAKE HIGH SPEED INTERNET ACCESSIBLE

In recent years Harrison County has made significant investments in high speed internet infrastructure. Still, not all areas of the county have access. Topography and cost are barriers in our rural community. However, the importance of students and families having access to on-line learning is more critical now than ever due to COVID-19.

GEER GRANT FOR E-LEARNING

Thanks to the hard work and perseverance of Harrison County Educator Allison Schalk, Harrison County was awarded a grant from The Governor's Emergency Education Relief (GEER) Initiative. Allison took the lead role in the state-wide application process. Three public school corporations, Lanesville Community Schools, North Harrison Community Schools, and South Harrison Community Schools and two private schools, St. John's Lutheran School and St. Joseph Catholic School were collaboratively awarded \$404,700.

The state directed the bulk of GEER funding be used toward subsidized subscriptions for targeted families. The participating schools worked together to determine high priority zones and coordinate the subsidized subscriptions. The parameters of the state awarded grant included securing local support. HCCF provided \$324,299.22 in grant funding as leverage to help increase the coverage area through infrastructure development in areas identified by the schools as priority zones. Local internet providers made significant financial investments to contribute to the success of the project. As a result, progress was made toward the ultimate goal of increasing internet connectivity for students to be able to access E-Learning. But there's still more to do.



“The GEER Grant and the support from the Community Foundation really reignited a much-needed discussion about reliable and affordable internet in Harrison County. I am thankful the Foundation stepped up to help the schools, students, and teachers by allowing us to target specific areas of expansion based on our student demographics and needs. BROADBAND READINESS PLAN

To address the big picture, the Chamber of Commerce of Harrison County and HCCF partnered to hire an outside consultant to create a Broadband Readiness and Infrastructure Deployment Plan for the county. HCCF provided \$50,000 toward the effort.

A broadband plan defines minimum broadband internet, surveys current broadband services, determines best technology infrastructure, and identifies specific actions that could be taken to address the lack of service in many parts of the community. The final deliverable from the consultant will be presented in 2022 and will provide a road map for key stakeholders in Harrison County to consider to further expand internet access.

LEGACY

Memories or knowledge that comes from the past

THE GREATEST GENERATION KEEPS ON GIVING

Jack and Evelyn Baker lived through tumultuous times. They experienced huge cultural shifts in society, lived frugally due to economic depression and sacrificed to win a war. They also left a generous lasting legacy. Their story illustrates why they and many of their peers are called “the Greatest Generation.”

Jack and Evelyn met in the 5th grade. Evelyn was an only child. Her father never got the opportunity to finish high school while her mother worked in a cigarette factory.

At age five, with a note in his pocket, Jack was sent by Greyhound Bus to live with his grandparents in Evansville, Indiana. After his grandparents died Jack lived with an aunt. With the help of a county judge he met at church, he became emancipated at age 16. He promptly enlisted in the United States Navy and served in the South Pacific on the USS Iowa. He witnessed both great and terrible events during World War II. In 1945, while home on leave, Jack married his childhood sweetheart Evelyn. All total, Jack served 12 years in the military, including a stint in the Sea Bees.

After his time in the military, Jack came back to Evansville and began working for Mead Johnson & Company. He and Evelyn had one son. They were active in various veteran groups including the Veterans of Foreign Wars, The American Legion and the Disabled American Veterans. Evelyn’s family became Jack’s family. In particular, Evelyn’s first cousin, Brian Gerald Walker, became his best friend.

Gerald, as he was called, served in the Korean War. He moved to Kansas City after the war and started a motorcycle dealership. Gerald never married. His business was successful, and he remained a good friend of Jack’s.

Years later, after Jack retired, he and Evelyn moved to Harrison County to be closer to their son who now lived in Corydon. They led a quiet, simple life. At one point they lived in Blue River Services’ Country Trace Apartments for seniors in Palmyra. When Gerald passed away they received an inheritance which allowed them to begin expressing their generosity.



Saying “education can make life better”, they created the Jack and Evelyn Baker Scholarship Fund which provides support for Harrison County resident graduating high school seniors with strong grades, but a financial need to attend college.

Jack and Evelyn felt a deep commitment to their church as well. They created The Epiphany Lutheran Church Fund which provides general support for the church, located in New Salisbury, Indiana.

Using the inheritance, Jack and Evelyn established a trust which provided funds for their care. By naming HCCF in their estate plans, they became members of the Trace Society. After they both passed away, the majority of their assets, nearly \$850,000, transferred to the Community Foundation to support the two funds they had previously established. Their actions set the stage for life changing scholarships for students and ongoing support for their faith within the community.
